The only "downside " has been during school holidays/general holiday time when holiday makers come to the town into the holiday homes dotted around the town and we experience car vandalism i.e. key scrapes on paintwork, pot plants thrown onto cars. This does not happen for the rest of the year which seems to indicate that our own young community have a general respect for their own.
- We have lived in Bampton for 35 years, brought our children up here and worked locally. Our lives here have been satisfying and enjoyable. The town, itself, however, is in urgent need of some TLC; the road through the town centre is a patched up mess and the pavements are uneven and have no consistent style. Scant notice is taken of double yellow lines. Vehicles particularly park on the pavements and in the leats. Walking through the town is often more like walking through a car park. Check out the civic pride (investment) in old towns and villages in France and Germany.
- o It seems a pleasant place to have settled
- Bampton is a superb community in which to live. There is a good range of shops, parking is adequate (and interesting) at times. I feel strongly that we need a new village hall with modern facilities; I am disappointed that we have been unable to find a new site for such a building.
- Having lived here for 27 years we find life in Bampton very agreeable. Very few problems of any sort. We could do with a new better hall to match other communities but where??
- We do appreciate the lifestyle we lead in Bampton and the sense of community that exists in this small mid-Devon town. However, we are concerned about the amount of development that is proposed. Indiscriminate parking, double parking, lorry unloading, make traffic flow awkward and dangerous. Castle Street only allows traffic 'up or down'. A head on collision waiting to happen.

- Preserve and improve what we have. Moderate development to prevent stagnation and keep services. Stop complaining about traffic and parking – the current informal system works.

- We are also very concerned about the speed of traffic. Again heightened awareness due to helping toddlers cross the road though even when we are walking on the pavement the speed of cars can be frightening.

- Limit parking in Castle street

- Traffic problems are caused by stressed up town people moving here who cannot wait a few minutes

- As with being local 'born and bred', we are content with the town and all it has to offer. We are concerned about the future development in regard to the position of new housing, thinking that 'in fill', is a better alternative. Also in common with a lot of other families, we are concerned with the traffic problems in Brook Street /Castle Street.
- We should not be building housing estates in an area of natural beauty, so close to the National Park of Exmoor.
- Housing providing housing without jobs is a problem waiting to show itself and if Bampton grows too large it will lose it's community spirit.

Halls

- o New Riverside Hall or total revamp. The Albert Fowler room is very smelly

- o It's great having 2 halls in Bampton but the Riverside Hall could be so much better than it currently is.
- Developing the recreation area with a hall/clubhouse for community use and sports to replace the Community Hall and Riverside Hall always seems a missed opportunity. Bampton Fair could go up there and the car park at Station Road made smaller (i.e. more efficiently laid out) and more attractive. Would the bridge or Swan like an area to serve drinks in the summer like in European cities?

Remaining Other or Combined Comments

- New people moving to Bampton with new ideas start things, move away, leaving others to pick up the pieces afterwards
- Old school site is an eyesore
- Distance to secondary school
- Street lighting to come back on at 5.30am
- Long term concerns about the economic viability of Bampton businesses, and the ageing population. Can see town becoming dead in 20 years time without some serious forward planning
- As an over 10 year resident of Bouchier close and user of the footpath from the close to Frog Street, I fear that when Bouchier Close is extended this short cut will be used by tearaway teenage cyclists. To prevent pedestrians being killed by cyclists riding down this 1:4 path, some kind of contraption and notice should be placed at either end of the path to prevent this use. There is also the possibility of some not negotiating the right angle bend at the bottom and being thrown over the wall into a moving vehicle in Frog Lane. Over the years there have been only two regular riders of this path one moved away some years ago and the other, at least at week-ends seems to have taken to his legs.
- o Possibly evening events e.g. concerts and theatre as no late return bus
- Many people call Bampton a village if it had this status then housing growth would/could be limited:- so the "village feel" could more easily maintained. Also the increasing pressure on the sewers/water/flooding/need for extra companies /schooling etc, etc would be more easily controlled.
- Bampton is a very attractive place to live if you are retired. It has everything you need it's USP.
 There is nothing here for young professionals and property is very expensive. Having affordable housing for local people is essential if the can't find work further afield.
- Local planning needs a total rethink. To build housing stock in unsuitable areas, with limited aesthetic or quality control with no regard to "Historical in keeping" seems to be gaining momentum, here inexplicably, as school is full, & there are no proper public footpaths, no proper transport OR facilities, no cycle paths. Closest adult cinema is "Exeter". Closest rec facilities are Tiverton. CARS seem to be "vital necessity" yet cause problems & issues here. There are empty unused stock & derelict Foundations within & at, the outer environs of Bampton yet there seems to be ill thought out plans for massive clusters of unsuitable housing to be planned, regardless. It makes on sense at all.
- Quiet cul-de-sacs & res areas are considered to be easily decimated, do not understand this outlook. The fabric of Bamoton should be considered FIRST & then its work, facilities, and transport

- plans, and cycle paths WHEN all those are in place: housing, (restricted, & in Entirely suitable areas) could be then considered.
- Town over crowded already with cars, and not enough parking. Many of the Bampton residents do most of their shopping in Tiv (Morr + Tesco) and do not support the excellent local shops, so do not build any more houses, except old school site, build in Tiv near the motorway.
